Environmental Information Regulations 2004 Request Contaminated Land enquiry 10/12 **Artillery Street**

I refer to your EIR request as above and respond as follows:

1) Do you hold any records relating to contamination issues, pollution incidences or public complaints associated with the subject site or surrounding sites?

The Environmental Health Service currently holds no information relating to contamination issues, pollution incidences or public complaints associated with the subject site or surrounding sites.

You may wish to refer to the Ordnance Survey Northern Ireland (OSNI) historical map database to obtain information on previous land-use within the vicinity of the site.

You may also wish to contact the Northern Ireland Environment Agency (NIEA) to determine if they have any other records of pollution incidences in the vicinity of the site.

2) What information do you hold with respect to past industrial uses of the subject site and surrounding sites? Please provide details.

The Environmental Health Service holds no information with respect to past industrial uses of the subject site or surrounding sites.

The EHS holds no information that indicates that the subject site or surrounding properties have been affected by the migration of landfill gas and/ or leachate.
- 6) What information do you hold with respect to site investigations / remediation work at the subject site and surrounding sites? Please provide details. The EHS holds no information with respect to site investigations / remediation work at the subject site or surrounding sites.
- 7) Have the subject site/ surrounding sites been or are they likely to be, the focus of investigations by the local authority?

The site and surrounding sites are not subject to investigation by the local authority.
