In relation to Premises Licence please see response provided below:

There is no legal requirement or provision in the legislation in NI for the licensing of food businesses. Under the Food Law Code Of practice, all food businesses must register with their Local Authority prior to opening, but this does not incur a fee and we cannot refuse to register any premises.

In relation to Caravan Site Licence please see response provided below:

In terms of the caravan site licence, Council have not issued any caravan site licences as yet although Council have two applications received for Travellers caravan sites within the area, so in answer we do not have any premises that hold a caravan site licence.

If you are dissatisfied with our response you have rights of review and appeal; these rights consist of two review processes.
