NOTES FOR GUIDANCE

1. Derry City & Strabane District Council is committed to ensuring a clean and safe environment. Under The Clean Neighbourhoods and Environment Act (Northern Ireland) 2011, section 43. Fouling of land by dogs and the removal of dog faeces. Failure to do so may result in a £80 fixed penalty and/or a maximum fine of £1000.
2. Dogs must always be accompanied by a responsible person and preferably controlled by a leash when in a public area. Dogs must be secured within the property at which they are kept and not allowed to stray.
3. If a dog should attack someone or 'behave in such a manner so as to cause a person apprehension of being attacked' then under the above legislation formal action may be taken.
4. From 9 April 2012 all dogs must be microchipped and licensed.
